In 2023, the Social Working Committee met nine times, using both virtual and face-to-face formats. The Social Working Committee has also set dates for 10 meetings in 2024, including four in-person.

In November 2023, the committee met in Membertou for two days of agenda-packed meetings, including presentations by Tiffany Lee, Director of Strategy for the Nova Scotia Native Women's Association; Rosie Sylliboy, Executive Director of Mawita'mk Charitable Society; and Conrad Saulis, Executive Director of the Wabanaki Council on Disability.

A sub-committee continues to develop a Project Fund application for a homelessness project spearheaded by the Mi'kmaw Native Friendship Centre and hopes to submit its application in the new year. In addition, the committee is updating its work plan and looking into opportunities to collaborate with other tables on projects with shared priorities.

Our most recent meeting was on March 4<sup>th</sup> at the Confederacy of Mainland Mi'kmaq's location in Millbrook.

## JUSTICE WORKING COMMITTEE

The Justice Working Committee aims to facilitate discussions among Nova Scotia Mi'kmaq, the Province of Nova Scotia, and the Government of Canada to address justice issues for the Mi'kmag community. It focuses on developing culturally appropriate justice services and providing a cooperative framework for collaborative planning and action. The committee strives to promote inclusive community safety through culturally relevant programs, including dispute resolution services and initiatives based on traditional Mi'kmaa Customary Law. Furthermore, it seeks to uphold Mi'kmaw justice concepts through consultation with Mi'kmaq communities and relevant government agencies, ensuring accountability, efficiency, effectiveness, equity, and financial stability in the delivery of Mi'kmaq justice services. The committee's work is guided by the principles outlined in the Royal Commission on the Donald Marshall Jr. Prosecution (1989) and the Royal Commission on Aboriginal People Bridging the Cultural Divide (1995).

Kara Pictou, hailing from Epekwitk (Prince Edward Island) and Paqtnkek First Nation (Nova Scotia), serves as the Chapter Liaison for the Nova Scotia Native Women's Association. Her primary role involves bolstering the capabilities of sixteen chapters through the compilation of research, communication strategies, advocacy initiatives, and fostering engagement.

In addition to her duties, Kara represents Indigenous women in Nova Scotia by participating in quarterly meetings with the Justice Working Committee and the Tripartite Forum. Subsequently, she provides comprehensive updates to the NSNWA Executive Director, relevant staff, and Chapter Presidents regarding issues affecting Indigenous women.

With a solid academic foundation, including a Bachelor of Science from St. F X in 2018, Kara possesses firsthand experiential knowledge that underscores the importance of integrating lived experiences into policymaking. She acknowledges that for experiential knowledge to effectively inform policy, it must not only reflect lived experiences but also be translated into policies understandable by policy actors.

Kara's objectives include strengthening working relationships within the Justice Working Committee, ensuring robust representation, and consistent engagement of Indigenous women. Furthermore, she plans to advocate for the expansion of court worker services to encompass family court, drug treatment, and domestic violence courts, with a focus on supporting underrepresented Indigenous individuals in civil matters.

As a Mi'kmaw woman, Kara is committed to advocating for the recognition of Indigenous women as knowledge bearers and promoting the integration of their knowledge sharing, experiential knowledge, and research into decision-making processes at all levels of government.
